Discussion- a 60" screen TV is being used and it provides ample display. James hopes people were becoming complacent with the streaming and won't attend church on the week's of the streaming service. Fellowship gatherings have started which the congregations

enjoy. The format of the service was discussed with people offering to read Scriptures. Steinbach and Niverville share their worship and share in each service. Some discussion about using different platforms- Google Meet, Zoom but YouTube is currently being used although is only a one way presentation.

Baptism – some people they don't want their child's baptism on YouTube – churches should adjust their service so it meets the family's needs.
